This action challenges defendants' past and ongoing violations of their obligations under Section 7 of the National Voter Registration Act of 1933 (the "NVRA"), 42 U.S.C. § 1973gg-5, which requires public assistance offices in covered states to distribute a voter registration application with each application for public assistance, and each recertification, renewal, or change of address relating to an individual's receipt of public assistance. It also mandates that these offices assist clients in completing a voter registration application, provide a form that asks clients whether they wish to register to vote and includes specified information, and accept completed forms.
